Active Ingredient Summary

Each of the human hair follicles contains melanocytes that are responsible for producing the natural pigment in hair. These melanocytes are genetically programmed to produce pigment for a certain number of years, after which they stop. Hair grows out unpigmented in a shade of grey, white or silver. Once the hair stops producing pigment, this cannot be reversed.

There are some medical conditions that can lead to premature greying, such as thyroid disorders, vitiligo and anemia. Certain factors, such as stress and smoking, may contribute to grey hair, but are not determining factors and, ultimately, the deciding factor in how quickly the hair goes grey is encoded in our genes.

The most common way of reversing grey hair is to do it cosmetically by colouring the hair, although hair colourant is not selective and will colour all of the hair, often with unnatural and conspicuous results. More natural, subtle and discrete is the use of a formula containing bismuth citrate and other active ingredients featured in Grey Away.

In the cosmetic industry, dyestuffs have been employed in various forms primarily for the coloration of human hair. In such applications, numerous limitations have been placed upon the dye systems based on concerns for human safety and exposure to substances having high toxicity, as well as other adverse effects on the user's skin or hair tissue.

As a safe and effective ingredient, Bismuth-containing dyeing systems have been employed for use in the colouration of human hair, particularly for applications involving the darkening of greying hair either in men or women. In bismuth-based formulations, other chemicals are deployed to ensure a safe and effective chemical reaction with human hair.

Bismuth on its own would result in a relatively poor level of colouration due to the time taken to dye the hair. However, with the addition of Sulphur and Triethanolamine, the chemical reaction becomes more efficient and faster due to their catalytic action. Bismuth and Sulphur ions are made available in the hair treatment formula, allowing them to penetrate the hair fibre and impart a brownish-black colouration to the hair.

Panthenol

Panthenol is formed from pantothenic acid, more familiar as Vitamin B5.

Panthenol binds well to hair follicles, and attracts moisture from the air and hence it is a moisturizing agent often used in shampoos and conditioners. It lubricates the hair without feeling greasy. It smoothes roughened hair surfaces, making them shiny and easier to comb.

Panthenol is safe to use as a skin product and is also used in ointments and creams - it can soothe the skin reducing the effects of sunburn, dry skin, and certain skin disorders.
